P3t is also open to young researchers contributions.

Articles deal with a wide range of public policies and territorial issues including:

- territorial development
 - Local-global: territory and knowledge economy
 - Development strategies
 - Development elements (e. g. innovation, activity location, human capital, social capital,...)
 - Planning and sustainability
 - Territorial scales (rural, urban and metropolitan areas)
- Policies and territorial impact
 - Labour policies and management policies
 - Wellbeing and social services policies
 - Social exclusion and urban segregation
 - Infrastructure
 - Mobility and communication systems
 - Environmental sustainability

- Territorial governance
 - General and sectorial local policies
 - Multi-level governance
 - Government and local institutions
 - Local democracy and citizen participation
 - Coordination and cooperation between social actors
 - Policies of Planning and evaluation
 - Community, citizenship and identity

Articles submitted to the journal should be original contributions and should not be under consideration for any other publication at the same time.

Research section papers are based on a blind peer-review procedure. Submitted manuscripts are rendered anonymous and sent to two accredited reviewers to be evaluated.
